A complete schedule of all process water and industrial wastes produced or expected to be produced at said property, including a description of the character of each waste, the daily volume and maximum rates of discharge, representative analyses, and compliance with any applicable Pretreatment Standards or Requirements.
4. The name and address of the person or firm who will perform the work covered by this permit.

In consideration of the granting of this permit the undersigned agrees:

1. To furnish and additional information relating to the installation or use of the water/sewer for which this permit is sought as may be requested by the City.
2. To accept and abide by all provisions of the City of Ludington's Pretreatment Ordinance, ARTICLE VI. SEWER SYSTEM DISCHARGE RESTRICTIONS AND PRETREATMENT REQUIREMENTS, and of all other Pertinent Ordinances or regulations that may be adopted in the future.
3. To operate and maintain any waste pretreatment facilities, as may be required as a condition of the acceptance into the wastewater treatment system of the industrial waste involved, in an efficient manner at all times, and at no expense to the City.
4. To cooperate at all times with the City and its representatives in their inspecting, sampling and study of the wastes, and any facilities provided for the pretreatment.
5. To notify the City immediately in the event of any accident, or other occurrence that contributes to the wastewater treatment system any wastewater or substances prohibited or not covered by this permit.

## WATER/SEWER DEPOSITS AND CONNECTION FEES

### Water/Sewer security deposits and connection fees

The applicant shall deposit the sum of \$500.00 as security for the performance of the work to complete such connection and restoration. If the person shall not complete the work, the city may, but shall not be required to, finish the work and be reimbursed from such security deposit for its cost. To the extent that such cost of completion and restoration exceeds the amount of the deposit. Such excess shall be paid by the applicant. If the applicant shall fail to make such payment, the amount shall be a lien on the property and placed on the next city tax bill for the property. (Code 1984, 2.182)  
Water security deposits and connection fees (continued)

The water connection fees are as follows:

For new taps for 12 inch mains and under;

1. Three-fourths inch tap \$235.00
2. One-inch tap \$245.00
3. 1 ½ inch tap, \$300.00, plus labor and materials.
4. 2-inch tap, \$330.00, plus labor and materials.
5. Over 2-inch tap, \$450.00, plus labor and materials.

For new taps over 12 inch mains;

1. Three-fourths inch tap, \$235.00, plus labor and materials.
2. One-inch tap, \$245.00, plus labor and materials.
3. 1 ½ inch tap, \$300.00, plus labor and materials.
4. 2-inch tap, \$330.00, plus labor and materials.
5. Over 2-inch tap, \$450.00, plus labor and materials.

For replacement taps 12 inch mains and under;

1. One-inch tap, \$150.00.
2. 1 ½ -inch tap, \$200.00, plus labor and materials.
3. 2-inch tap, \$250.00, plus labor and materials.
4. Over 2-inch tap, \$350.00, plus labor and materials.

For replacement taps over 12 inch mains;

1. One-inch tap, \$150.00, plus labor and materials.
2. 1 ½ -inch tap, \$200.00, plus labor and materials.
3. 2-inch tap, \$250.00, plus labor and materials.
4. Over a 2-inch tap \$350.00, plus labor and materials.
